

## DIRECTORY OF FEDERAL REGIONAL STRUCTURE.

This publication is designed to provide current information about the Federal regional structure.

The standard Federal administrative regions were established to achieve greater uniformity in the location and geographic jurisdiction of Federal field offices. The Office of Management and Budget Circular No. A-105, *Standard Federal Regions*, provides further guidance on the policies and requirements governing the standard administrative regions. Agencies are now required to adopt the uniform system when new offices are established.

A map of the Standard Federal Regions and tables listing the key officials, addresses, and telephone numbers of the agencies conforming to the system can be found on pages 1 to 12. The regional maps and tables of those agencies not conforming to the 10 Standard Federal Regions begin on page 12.

The Federal Regional Councils were established by Executive Order 11647 of February 10, 1972, in each of the 10 standard Federal regional cities. Further information regarding the functions and membership of the Federal Regional Councils can be found on pages 858 and 859 of the 1979/80 *United States Government Manual*. Information on Federal Regional Councils or OMB Circular No. A-105 can also be obtained from the Intergovernmental Affairs Division, OMB, Washington, D.C. 20503.
