Introduction

This directory is designed to provide information on state and local agency officials involved in implementing the urban transportation planning process required by Federal Highway and Urban Mass Transportation legislation. It was developed in response to requests for names and identification of persons and organizations involved in the urban planning process. The Federal Highway Administration (FHWA) and Urban Mass Transportation Administration (UMTA) legislation requires that each urbanized area, have a continuing cooperative and comprehensive transportation planning process that results in plans and programs consistent with the comprehensively planned development of the urbanized area. This process is required as a condition to the receipt of Federal capital or operating assistance. The most recent designation of urbanized areas followed the 1980 Census and subsequent modifications to the criteria for urbanized areas.

The Metropolitan Planning Organization (MPO) is that organization designated as being responsible together with the state for carrying out the urban planning process. The designation is made by agreement among the units of general purpose, local government, and the Governor. The MPO acts as the forum for cooperative transportation decisionmaking.

There are several types of arrangements represented on the lists of MPOs. Though in most instances only one agency is designated for an urbanized area, there are some instances where it was necessary to designate two or more organizations to work cooperatively as the MPO.

This directory has been compiled in two sections. Section I includes the designated MPO, transit operator and key official for each of the urbanized areas named following the 1980 Census. Transit operators have been included because of UMTA's advocacy of appropriate transit operator involvement in the urban transportation planning process. Section II includes the name and chief executive of each state department of transportation and/or highway agency. All the lists include the title, address, and phone number of the key officials. Both sections are arranged in alphabetical order by state. The standard Federal Region for each state is included under each state name.

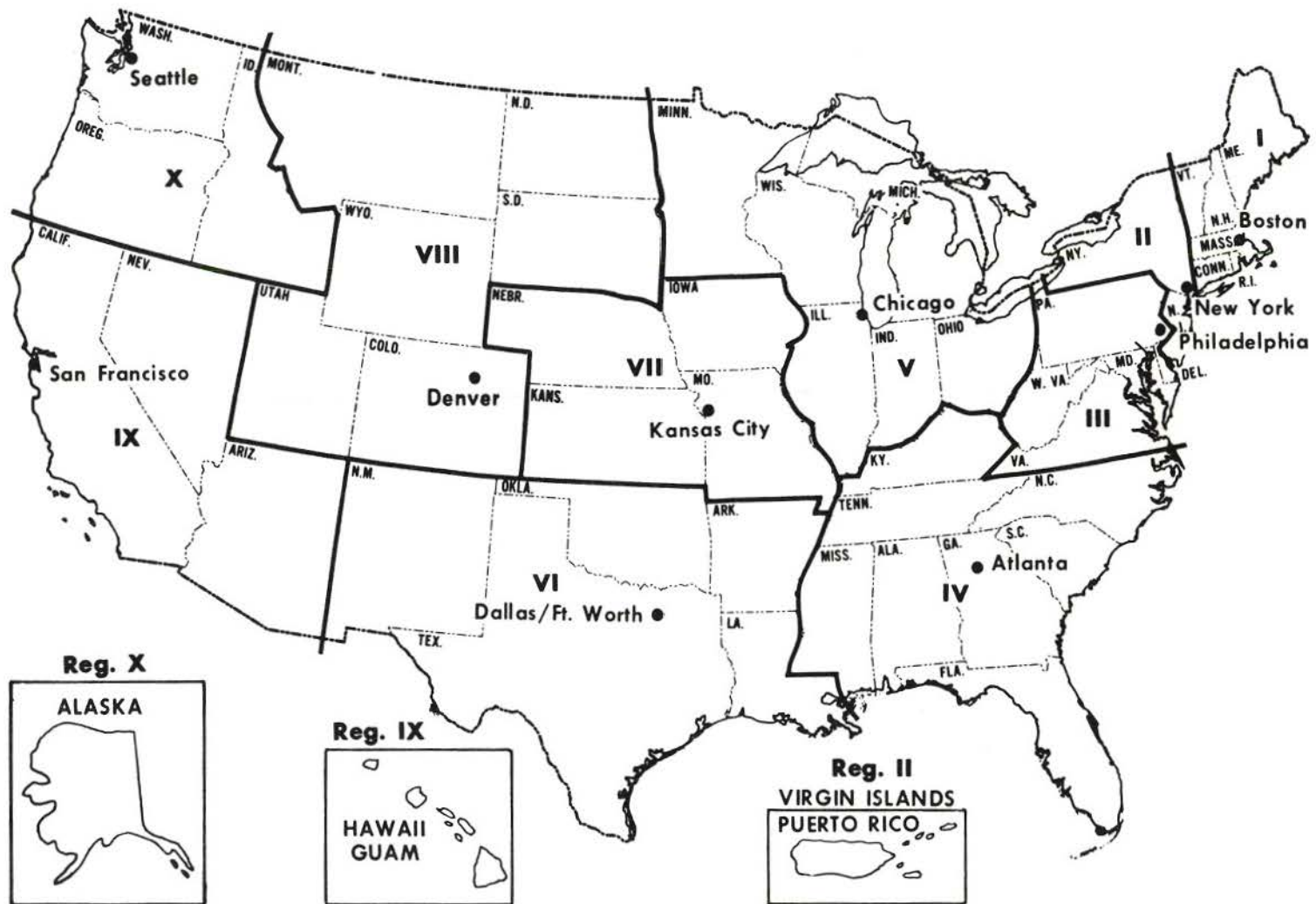
All of the information on MPOs and state agencies was provided by the top official in the state DOT and/or highway department or his designated alternate. Transit operator information was obtained from UMTA, American Public Transit Association (APTA) and Census documents.
