To Recipients of the MPO Directory:

Historically, the metropolitan planning organizations (MPO's) serving this country's urbanized areas have played a key role in weaving the various individual modes of transportation into coherent regional transportation systems. These groups have had the responsibility for conducting integrated urban transportation planning and helping establish the funding priorities for needed improvements in their areas.

The role of the Metropolitan Planning Organizations has been recently re-emphasized in the Intermodal Surface Transportation Efficiency Act of 1991. As Section 1024 of the Act states:

It is in the national interest to encourage and promote the development of transportation systems embracing various modes of transportation in a manner which will efficiently maximize mobility of people and goods within and through urbanized areas and minimize transportation-related fuel consumption and air pollution. To accomplish this objective, metropolitan planning organizations, in cooperation with the State, shall develop transportation plans and programs for urbanized areas of the State.

The Act emphasizes that such planning must be intermodal, as well as continuing, cooperative, and comprehensive.

This directory is intended to help practicing transportation planners and other transportation professionals locate the organizations and persons working in the urban planning process. It summarizes the metropolitan planning organizations serving major metropolitan areas, along with contacts in each. It also presents the major transit agencies serving these areas and the state planning contacts who work with the individual localities.

The last edition of this directory was issued in 1985, and a substantial number of changes have occurred since then. A good number of smaller communities have grown into urbanized areas and are appearing here for the first time. A number of the other entries reflect relocations and staff changes. Whenever possible, we have tried to obtain updated information directly from the organizations involved.

I hope this document contributes to improving transportation planning in your area and would welcome your comments on the document.

Introduction

This directory is designed to provide information on State and local agency officials involved in implementing the urban transportation planning process required by the Federal highway and transit legislation. It was developed in response to requests for persons and organizations involved in the urban planning process, and reflects the most recent designation of urbanized areas based on the 1990 census. The Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) legislation requires that each urbanized area have a continuing cooperative and comprehensive transportation planning process that results in development of the urbanized area. This process is to be continuous and include public involvement. A long-range plan for all areas of the State is to be coordinated with the MPOs in all metropolitan areas. This planning is required as a condition to the receipt of Federal capital or operating assistance.

The Metropolitan Planning Organization (MPO) is that organization designated as being responsible together with the State for carrying out the urban planning process. The designation is made by agreement among the units of local government and the Governor. The MPO acts as the forum for cooperative transportation decisionmaking.

There are several types of arrangements represented on the lists of MPOs. Though in most instances only one agency is designated for an urbanized area, there are some instances where it was necessary to designate two or more organizations to work cooperatively as the MPO.

This directory is compiled in two sections. Section I includes the designated MPO, transit operator, and key official for each of the urbanized areas named. Transit operators have been included because of FTA's advocacy of appropriate transit operator involvement in the urban transportation planning process. Section II includes the name and chief executive of each State department of transportation and/or highway agency. All the entries include the title, address, and telephone number of the key officials. Both sections are arranged in alphabetical order by state.

Since the last publication of this directory was in 1985, this data has received extensive review and updating. An attempt was made to directly contact each MPO, transit operator, and State transportation office for updated information to list in this directory. The changes were extensive, and since organizations continue to reorganize, additional changes are always in progress.

In order to provide an accurate tool for all users of this directory, your assistance is requested to provide any information that would correct or supplement the entries in this directory. A blank, formatted page is located at the end of this directory for this purpose. Please send your revisions to MPO Directory Change (DRT-10), Technology Sharing Program, U.S. Department of Transportation, Washington, D.C. 20590.
