**SUBJECT: RAIL WINDOW VANDAL PROTECTION SHIELDS**

**ACTION: AWARD CONTRACT FOR RAIL WINDOW VANDAL PROTECTION SHIELDS**

**RECOMMENDATION**

Authorize the Chief Executive Officer to award a 24-month, firm fixed price contract under Bid 03-0008 to Graffiti Removal Inc., the lowest responsive, responsible bidder for Rail Window Vandal Protection Shields for an amount not to exceed \$252,146, inclusive of sales tax.

**RATIONALE**

Vandal shields protect the windows from graffiti markings and vandalism, thus avoiding permanent damage to the windows as well as reducing parts and labor costs. These vandal sheets are required to maintain the appearance of the rail cars and are replaced as necessary. Replacement of the vandal shields is in compliance with our Zero Tolerance program.

The vandal shields have been adapted to conform to specific requirements for each of the rail line cars in terms of the type of material, adhesive, dimensions and application process.

**FINANCIAL IMPACT**

Funding of \$126,073 for these vandal shields will be included in the FY04 budget and subsequent budgets in Cost Center Number 3940, Line item 50441, M&S Parts, Revenue Vehicle, Task 5.2, Rail Equipment Maintenance under Project 300022, Metro Blue Line Purchase Parts, Project 300033 Metro Green Line Purchase Parts, Project Number 300055, Metro Gold Line purchase parts and 300044, Metro Red Line purchase parts. Since this is a multi-year contract, the cost center manager and Deputy Chief Executive Officer will be accountable for budgeting the cost in future years. In FY02, \$175,134 was expended on this category.


## **ALTERNATIVES CONSIDERED**

The alternative is not to award the contract and continue to procure vandal shields on an as-needed basis at a higher cost. This approach is not recommended since it does not provide for a firm fixed price or a commitment from the supplier to ensure availability.



## **ATTACHMENT A-1 PROCUREMENT HISTORY**

### **A. Background on Contractor**

Graffiti Removal Inc., was founded in 1976 and is located in Huntington Beach, CA. Graffiti Removal, Inc. operates as a retailer/wholesaler of pre shielding protective for glass, primarily used to prevent graffiti. They also provide contracting services specializing in graffiti removal.

Graffiti Removal Inc. has provided satisfactory service and products to the MTA.

### **B. Procurement Background**

In accordance with the MTA's Procurement Policies and Procedures, Engineering Department performed a technical evaluation of seven bids that were received. The two apparent lowest bidders were determined to be non-responsive to the specifications.

### **C. Evaluation Criteria**

Technical review and selection of the lowest responsive, responsible bidder.

| Bidder #4 | West Coast Gasket in the amount of \$285,804 was in full compliance with the technical and the bid specifications; however, they were not the low bidder on this item.                               |
| Bidder #5 | 3M Center in the amount of \$299,101 was in full compliance with the technical and the bid specifications; however, they were not the low bidder on this item.                                       |

**Bidder #6** Laird Plastics in the amount of \$259,154 is in full compliance with the technical and the bid specifications; however, they were not the low bidder on this item.

**Bidder #7** J.T. Nelson in the amount of \$1,133,428 is in full compliance with the technical and the bid specifications; however, they were not the low bidder on this item.

**D. Cost/Price Analysis Explanation of Variances**

The recommended bid price of \$252,146 has been determined to be fair and reasonable based upon adequate price competition and selection of the lowest responsive and responsible bidder.
