



**NOTICE OF PUBLIC HEARING**  
**Los Angeles County Metropolitan Transportation Authority**  
**Metro Westside/Central Sector**

The Westside/Central Service Sector will hold a public hearing in August 2004. The purpose of the upcoming public hearing is to receive public comments on proposed changes to MTA bus service operating in the Westside/Central Sector. Approved changes will become effective December 19, 2004 or later.

The hearing is being held in conformance with federal public hearing requirements outlined in Section 5307 (d) 1 of Title 49 U.S.C., and public hearing guidelines adopted by the MTA's Board of Directors in 1993, as amended.

The affected bus lines and service proposals under consideration are listed below. Adjustments to these services are recommended to improve productivity, eliminate duplication of service, and improve transit travel time through the addition of new limited stop service.

217	Fairfax Avenue - Hollywood	Reduce weekday frequency of service on Route 217 during peak and off-peak hours. End route at Hollywood and Vine.
220	Robertson Blvd. – Culver Blvd. – LAX	Eliminate service all days of the week.
434	LA-Santa Monica-Malibu-Trancas Express	Eliminate service all days of the week.
787	Fairfax Av-Hollywood-Glendale-Pasadena (Metro Rapid)	Establish new rapid bus service along the Fairfax Ave., Hollywood Blvd., and Colorado Blvd. corridors.

## San Gabriel Valley Service Sector

LINE	LINE NAME	DESCRIPTION OF PROPOSED SERVICE CHANGE
78-378	LA-S. Arcadia via Huntington Dr.-Main St.-Las Tunas Dr	Establish new Line 378 weekday, peak-period, peak direction only Limited Stop service between Downtown LA and Las Tunas Dr. and Mission Dr. Line to operate weekday only, peak period, and peak direction only service. Convert selected Line 78 local trip to new limited service.
85	Cypress Av-Verdugo Rd.	Cancel line. Establish New Shuttle Line 685 to serve the segment of Verdugo Rd. between Eagle Rock Blvd. in the Eagle Rock area and Broadway in the City of Glendale. New Line 685 would also replace the Yosemite Dr. portion of Line 181.
181	Hollywood-Glendale-Pasadena-Pasadena City College-via Yosemite Dr.	Cancel Line. Establish new Shuttle Line 685 to operate replacement service between Broadway and Verdugo Rd. in the City of Glendale and Figueroa St. and Colorado Blvd. in the Eagle Rock area. Alternate service is available on all other discontinued segments.
255	Rowan Av.-Griffin Av.	Options Under Consideration: 1) Cancel line, or 2) Retain portion of the line between County General Hospital and Whittier Blvd. Various portions of the route duplicate service operated by DASH Lincoln Heights, DASH Boyle Heights, and MTA Line 46.
259	South Gate-Arizona Av.-Templeton St-El Sereno	Cancel the route segment between Huntington Dr and Monterey Rd. and Fremont Av. Portions of the route are duplicated by Alhambra (ACT), DASH El Sereno, and MTA Line 45 services.
380	Pasadena-Glendale-Hollywood	Cancel line and integrate into METRO Rapid Line 787.
787	Fairfax Av-Hollywood-Glendale-Pasadena (Metro Rapid)	Establish new rapid bus service along the Fairfax Av., Hollywood Blvd., and Colorado Blvd. corridors.
