## NOTICE OF PUBLIC HEARING

Los Angeles County Metropolitan Transportation Authority Metro Westside/Central Sector

The Westside/Central Service Sector will hold a public hearing on February 9, 2005. The purpose of the upcoming public hearing is to receive public comments on proposed changes to MTA bus service operating in the Westside/Central Sector. Approved changes will become effective June 26, 2005 or later.

The hearing is being held in conformance with federal public hearing requirements outlined in Section 5307 (d) 1 of Title 49 U.S.C., and public hearing guidelines adopted by the MTA's Board of Directors in 1993, as amended.

The affected bus lines and service proposals under consideration are listed below. Adjustments to these services are recommended to improve service quality, to use resources wisely, and to consider new options.

# PROPOSED CHANGES

### Westside/Central Service Sector

LINE	LINE NAME	DESCRIPTION OF PROPOSED SERVICE CHANGE
14	Beverly Blvd.	Reduce weekday frequency of service on Route 14 during peak hours and replace with new Metro Rapid Line 714.
58	Alameda St.	Cancel Line due to low ridership demand.
317	Fairfax Ave. – Hollywood Blvd. Limited	Replace service on Line 317 with new Metro Rapid Line 717.
714	Beverly Metro Rapid	Implement new Metro Rapid service between Beverly Hills and downtown L.A. along Beverly Blvd., 1 <sup>ST</sup> St., Grand Ave/Olive Blvd. to Washington Metro Blue Line Station. Service will be provided during weekday peak hours.
717	Fairfax Metro Rapid	Establish new Metro Rapid service between Hollywood/Vine Station and West LA Transit Center.

107	54 <sup>th</sup> St. – Fairview Blvd.	Reaffirm cancellation previously implemented in June 2004.
207/357	Western Av. – 120 <sup>th</sup> St.	Two proposals: (1) in Hollywood, restructure some trips to link with Line 204 (Vermont Av.) to reduce the number of buses operating on Garfield Place; and (2) in Los Angeles, consider elimination of the route segment on 120 <sup>th</sup> St. between Western Av. and the Harbor Green Line Station.
305	UCLA – W. Hollywood – Rosa Parks (Imperial/Wilmington) Station	Reduce service weekday; cancel service Saturday and Sunday.
357	Western Av. Limited	Cancel all service in December 2005 with implementation of Western Av. Metro Rapid Line 757
442	LA – Manchester Ave. – Hawthorne Blvd. Express	Cancel weekday service. Alternate service available on new Metro Rapid 740, Lines 315, and the Harbor Transitway Lines 444, 445, 446/447 and 460.
757	Western Av. Rapid Bus	Consider route, service periods, stops, and terminal locations for the Western Av. Metro Rapid expected to begin service in December 2005.
